# **Senator Young Visits SCS**

On Wednesday, October 29, 2008 Scio Central School (SCS) welcomed a very special guest for lunch. We were honored to host New York State Senator Catharine Young (R-Olean). Senator Young visited SCS to learn more about the \$36,000 grant funded by the New York State Education Department. The grant was written, and is currently administered by Doreen Trimm, BOCES cafeteria manager at SCS. The grant provides fresh fruit or vegetables to students and staff daily. Some of the fruits and vegetables provided to the students include different varieties of apples (some picked by our own sixth-graders in Castile), bananas, peaches, grapes, cauliflower, broccoli, green beans and carrots.

The grant is administered under the U.S. Department of Agriculture and targets schools in hopes of educating children about proper eating habits and to combat childhood obesity. Scio was one of only 26 districts across the state to receive the grant last June. Teachers at SCS model the behaviors they look for in their students by promoting healthy eating, exercise, and encouraging students to eat healthy alternatives to foods high in sugars and fats. Many teachers have noticed their students are more alert, and look forward to the delivery of the fruit or vegetables to classrooms each day.

During Senator Young's visit, she was able to take a tour of the building with school administration, a board of education member, Ms. Trimm, and Doreen Martin, supervisor – buildings and grounds (*see photo on opposite page*). During the tour, Senator Young also stopped in the elementary library, where a group of first-grade students were engaged in early literacy activities (*see photo below*). Senator Young took time to explain to the students her role in state government and how she helps to develop some of the laws students are familiar with.

The SCS community would like to thank Senator Young for taking the time from her busy schedule to visit our district.

# 8th Graders Are Planning For Their Future!

Students in the eighth grade have been spending the past few weeks focusing on career exploration. Students began their process with a classroom presentation at SCS by Gene Abbey, Career Services Counselor from the Cattaraugus-Allegany BOCES Career and Technical Education (CTE) Center at Belmont. Following the presentation, students continued their exploration with a self-discovery homework assignment, which required them to gather input from their guidance counselor, teachers, and family members.

On Thursday, October 23, the entire eighth grade traveled to the BOCES CTE Center at Belmont to participate in the Future Focus Program. Future Focus is a BOCES -sponsored program, which focuses on career areas of interest as indicated by surveys and input of area youth. Students spent part of the day making brief visits to BOCES Career and Technical Education classrooms and meeting with local business representatives such as Jones Memorial Hospital. Representatives from Alfred State College and Jamestown Community College also provided hands-on activities during lunch.


Students then spent the rest of the afternoon obtaining further information on a specific career discipline. This information included what type of post-secondary education will be needed to achieve the career; job skills; employment outlook and related jobs within the chosen career field.

Students in Mrs. Dunham's Home and Career class have taken their career exploration even further by taking an Interest Profiler with the assistance of Mrs. Crowell-Ketchner. By answering questions about their interest in common work activities, students were able to identify, through the Interest Profiler, matching work-related interest areas and suggested occupations for the students to further explore.

## Integrated Pest Control Management Plan

Under the regulation known as the Pesticide Notification Education law 409-h, the district is required to inform you of any use of a product listed in the law. Our district does not use any chemicals or pesticides that are listed.

Even though we are not required to write this letter, we believe it is important to inform you of how we will handle situations that might arise that require the use of any chemicals or pesticides. Our plan is designed to effectively manage pest control and continually monitor situations through feedback, routine checks and inspections. Members of our staff are trained as prescribed by law to apply any needed remedies.

We will be using the following products to control insects: baits, jells and granular products that contain boric acid and/or disodium octaborate techraydrate. We may also use growth regulators so pests do not mature and breed should they be brought into the school. Aerosol products are also used when necessary to deal with biting or stinging insects, such as hornets and venomous spiders.

# About Pesticides . . .

The Scio Central School District utilizes non-chemical solutions when pest removal from the district buildings or grounds is necessary. Traps, environmental modifications, and/or mechanical means are utilized to eliminate pests.

School law requires the district maintain, on an annual basis, a list of parents who wish to receive advance notice of pesticide application at the school their child attends. To have your name included, a formal request must be submitted. Forms are available in the district newsletter (see form at right), or can be obtained by contacting the school.

Rodent control will be accomplished by using cultural controls: such as regular trash pickup, cleaning up food scraps and other sanitation methods. Traps will only be used as a means of mechanical control when other methods are not conducive to the school setting.

Weeding will control unwanted vegetation, or if application of an herbicide should be necessary to control poison ivy or other harmful weeds, it will occur over a long weekend, which will nullify any harmful effects associated with the application.

Anti-microbial products have been excused from the notification law for practical reasons. Germs, fungi and molds need to be controlled for health reasons.

We will adjust and update the plan to ensure the safety and health of all building occupants.

I am the parent or guardian of dents with grade levels), who attend the Scio Central School District. It is my understanding that a school law may require every school on an annual basis to maintain a list of parents who wish to receive advance notice of pesticide applications at the school their child attends. Each time pesticides are scheduled to be applied at the school, parents on the list must be notified with a written notice at least 48 hours in advance of the application. The notice must specify the date and location of the application, the name and the EPA registration number of the product being applied; the name and number of the person at the school who can be contacted to discuss the precautions being taken to protect children and staff from exposure; and the telephone numbers of informational services that can provide specific information about pesticides being applied.

#### 7-12 Notes

# **Body Mass Index Assessment Now Required for Physicals**

According to research recently published in The Journal of the American Medical Association, young children spend an extraordinary amount of time moving about: an average of three hours a day at age 9. But in just a few short years, all that childhood energy disappears. By the age of 15, daily physical activity is down to just 49 minutes on weekdays and about a half-hour on weekends.

Due to the rising problem of childhood obesity and the possible health risks associated with obesity, school districts in New York state are now required with the April 2007 passage of legislation amending Education Law Sections 903 & 904 to assess a student's body mass during the required health appraisals at school entry, pre-kindergarten, and in grades 2, 4, 7, and 10.

This assessment is done as part of the school health examination. The student is weighed and his/her height is measured. These numbers are then used to figure out the student's body mass index or BMI. The BMI helps the doctor or nurse know if the student's weight is in a healthy range or is too high or too low. Selected schools will be asked to take part in a survey where no student names or specific information about individuals would be provided. If our school is selected, a student participation waiver is shown **AT LOWER RIGHT.** A similar form can also be obtained from the building secretary or nurse.

We have also printed some frequently asked questions **BELOW**. We hope they will answer any basic questions you may have about the new requirement. If you have further questions, please do not hesitate to call your child's principal or nurse. Thank you in advance for your continued cooperation.

#### Frequently Asked Questions

Why measure BMI and weight status in students?

There is a strong and compelling need for obesity prevalence data of school-age children and adolescents at the local and state level. The information collected will be used to understand the severity and distribution of obesity among youth of various ages in different regions of the state. This is a critical first step in targeting resources for childhood obesity prevention to high-risk communities.

The information will also be used to evaluate whether actions taken by local schools and communities to improve access to healthy foods and to increase physical activity are making a difference and reducing childhood obesity rates.

Does the legislation require that BMI or weight status data be reported to parents/guardians? The new legislation does not require reporting of BMI or weight status category to parents or guardians.

BMI and weight status category are to be added to the Student Health Certificate/Appraisal required by the NYS Education Law Sections 903/904. It is the responsibility of the healthcare provider who conducts the health examination to interpret the student's weight status category for parents/ guardians as part of the routine preventive care, and to provide counseling, follow-up and referral as indicated.

## **BMI Participation Waiver**

Dear Parent/Guardian:

As part of a required school health examination, a student is weighed and his/ her height is measured. These numbers are used to figure out the student's body mass index or "BMI." The BMI helps the doctor or nurse know if the student's weight is in a healthy range or is too high or too low. Recent changes to the New York State Education Law require that BMI and weight status group be included as part of the student's school health examination. A sample of school districts will be selected to take part in the survey by the New York State Department of Health. If our school is selected to be part of the survey, we will be reporting to New York State Department of Health information about our students' weight status groups. Only summary information is sent. No names and no information about individual students are sent. However, you may choose to have your child's information excluded from this survey report.

The information sent to the New York State Department of Health will help health officials develop programs that make it easier for children to be healthy.

#### **OT/PT Services Available**

#### Do you have a child who needs OT/PT services?

If you believe your child is struggling in any of the following areas -- fine motor skills, mobility/transitions, self-help skills, sensory processing skills, gross motor/postural control, behavior/social skills -- there is a screening process that can be done to determine if the child is in need of either service. The screening process is listed below.

Step 1 - Have teacher request an OT/PT screen form from the CPSE office or OT Department.

Step 2 - A teacher fills out the form completely, identifying areas of concern.

*Step 3* - Teacher returns the completed form to the CPSE office.

Step 4 - The CPSE Chairperson notifies the OT and/or PT department and gives them the student's information.

Step 5 - The OT and/or PT contacts the teacher to set up a scheduled time when the screening can be administered.

Step 6 - The OT and/or PT complete the screening.

Step 7 - The teacher, CPSE Chairperson, and the parents/guardian are given copies of the screening with the determination of whether or not the student requires further testing for OT and/or PT services.

#### Important Health Information

Parents, if you came to the parentteacher conference, or received your child's report card in the mail, you should have noticed a sheet called FITNESSGRAM for parents. These are a part of a federal grant our school received called PEP (Physical Education Program). The goal is to increase the physical activity of our students and improve their health as a result. One part of the program is this FITNESSGRAM. Here is what it is about...

People come in all shapes and sizes, but everyone can benefit from regular physical activity and a healthy level of physical fitness. The FITNESSGRAM evaluates five different parts of health-related fitness. You will see the results of each of these on the report. You, as parents, play an important part in shaping your child's physical activity and dietary habits. The report will help you evaluate your child's current level of healthrelated fitness and help you identify ways to promote healthy lifestyles in your family.

Your child will be doing these FIT-NESSGRAM activities once a marking period. Our goal is to see improvement throughout the year. Please be sure to read the FITNESSGRAM report you have received and use the information to help your son or daughter understand the importance of good health.



#### Physical Education Grant

The Physical Education Program Grant, also known as the "PEP" Grant has begun here at Scio C.S. Our school district, along with Bolivar-Richburg and Friendship Central Schools, were awarded this grant which will give each district \$800,000 for expenditures such as professional development training, transportation of students and physical education equipment and supplies, over the next three years.

One of the main areas of focus for the grant is to increase the amount of time spent by our students, grades K-12, in moderate to vigorous physical activity each week. Our goal is to achieve a minimum of 155 minutes/week for students in grades K-6, and 230 minutes/week for students in grades 7-12. This physical activity time can include many different areas, and can be achieved in different ways. Physical Education class time and any interscholastic team participa-

tion time will count toward our goal. In addition, any time spent at home, or away from school will be counted, as long as the activity is documented and is moderate to vigorous in nature. We are currently organizing many types of after-school activities for students who are not involved in the interscholastic program. Those minutes will count as well, and will be tracked by the teacher who is coordinating the activity. Parents should be watching for an individual survey to be coming home, for each student, where minutes spent and the activity chosen can be listed. This is an exciting time for the P.E. Department, and we hope to involve as many faculty and staff members to encourage maximum student participation.

# Mentoring- Changing Lives One Child at a Time

Did you know there's a Mentoring Center at Scio Central School? In order to make mentoring a reality for Scio Central students, we need your help. We're looking for volunteers to serve as mentors to students in grades 4-8. Applicants need to be at least 18 years of age and have a willingness to help others. A mentor is a good listener, a role model and caring advocate; someone who helps a young person to become the best he/she can be and encourages him/her to make healthy choices.

Cattaraugus-Allegany BOCES Youth Mentoring Program is a preventative program with a positive youth development approach. This site-based program aims to help young people experience a healthy adolescence and make a successful transition into adulthood. Community members can play a vital role in our quest to serve middle school youth in the area. Matches are based on a common interest, career, hobby, or sport. Mentors meet with their mentee once a week for approximately two hours from 4-6 p.m. in a safe and supervised environment. The mentoring schedule follows the school

calendar. Activities are provided, along with occasional educational/cultural field trips. Mentor applicants go through a personal interview and screening process. Each Mentoring Center has a site coordinator (certified teacher or counselor) to over see the matches, provide support and activities as needed.

The Mentoring Centers are open on assigned days at our 11 locations: Cuba, Wellsville Middle School, Houghton College, Genesee Valley Central, Scio Central (Mondays), Portville Central, Cattaraugus-Little Valley Central, West Valley Central and Randolph Central.

# Dental Exam Now Required for School Entry

As part of your child's entry for school, a physical examination has been required for all new entrants in pre-k, kindergarten, and grades 2, 4, 7, and 10. A new law was recently enacted that expands health screening to include the dental health of students in New York state.

As of September 1, 2008, we are requesting a dental health certificate to be completed in addition to a physical examination. There is a certificate available upon request for you to take to your child's dentist to be completed. Upon completion, please return it to the school nurse, as it will be filed in your child's Cumulative Health Record.

Please be advised that a physical examination is a requirement that has to be met to comply with New York State Law for attendance in public school. The dental certificate is a request and will not prevent a child from attending school if the request is not met.
